

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority is under said Act; and

WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and

WHEREAS, authority to grant disbursement of monies from the Three Affiliated Tribe's IIM account at the Bureau of Indian Affairs, Fort Berthold Agency; and

WHEREAS, disbursement in the amount of \$1,468.53 payable to Bartelson's Lumber Company, Parshall, North Dakota, for materials used to repair the Roping Arena, a tribally owned building, said costs were incurred from previous year;

THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby authorize disbursement of \$1,468.53 to Bartelson's Lumber Company for said purpose.

C E R T I F I C A T I O N
