WHEREAS, Authority to grant disbursement of monies from the Three Affiliated Tribes' IIM account at the Bureau of Indian Affairs, Fort Berthold Agency; and

WHEREAS, Disbursement in the amount of \$1,144.12 payable to James Johnson for Construction of Storage Building;

THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes, Fort Berthold Reservation, hereby authorize disbursement of \$1,144.12 to James Johnson for said purpose.
