WHEREAS, the Tribal Business Council has recently filled two (2) vacancies that occurred due to one death and one resignation and

WHEREAS, the Tribal Business Council must reorganize the respective committees left vacant in order to conduct necessary meetings for the benefit and well-being of all tribal members;

THEREFORE BE IT RESOLVED, that below listed Committees and council member composition shall be designated as the official Tribal Business Council Committees;
