

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and

WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and

WHEREAS, The Three Affiliated Tribes has developed a Tribal Specific Health Plan and forwarded to the Aberdeen Area Office, and

WHEREAS, The unmet health needs of the Three Affiliated Tribes are great and have not been fully covered in the Specific Health Plan, and

WHEREAS, The Indian Health guidelines had restrictions which did not allow fully documentation of unmet needs, and

THEREFORE BE IT RESOLVED that the following are areas of concern and need on the Fort Berthold Reservation and not fully covered in the Specific Health Plan:

1. Authorized positions for primary care providers for the Fort Berthold Reservation be filled immediately; and
2. Contract care funds increased to meet total years need rather than depending on supplemental appropriations each year;
3. Outlying clinics at White Shield, Mandaree, and Twin Buttes be fully staffed for 24 hour service with Family Nurse Practitioners/Physician Assistants and other staff;
4. Any addition of IHS appropriations for Fort Berthold is absorbed by rising costs and minimum service is provided for the Fort Berthold Reservation;
5. The Specific Health Plan requires use of IHS census for the Fort Berthold Reservation which excluded many residents. The Bureau of Indian Affairs census is up-to-date and gives accurate numbers of residents and should be used for the Health Plan.

C E R T I F I C A T I O N

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby certify that the Tribal Business Council is composed of 11 members of whom 7 constitutes a quorum, 9 were present at a Special Meeting, thereof duly called, noticed, convened and held on the 22 day of June, 1979; that the foregoing Resolution was duly adopted at such meeting by the affirmative vote of 9 members, 0 members opposed, 0 members abstained, and that the said Resolution has not been rescinded or amended in any way.
