- WHEREAS, The Fort Berthold Aging Services Program receives limited funding from the North Dakota State Social Services, and,
- WHEREAS, Additional monies are needed for the continued support for an effective nutrition and outreach program for the elderly, and,
- WHEREAS, Tribal Administration policy dictates support to the senior citizens of the Fort Berthold Reservation, and,
- WHEREAS, Due to inflation and the increase of senior citizen participation additional monies must be obtained, and,
- NOW, THEREFORE BE IT RESOLVED, the Tribal Business Council authorize assistance to the Fort Berthold Aging Services Program by providing \$7,218.00 to continue and promote the services of the program.
