

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes charge the Tribal Business Council of the Three Affiliated Tribes to protect and preserve the property, wildlife and natural resources of the Tribes, and
- WHEREAS, The only tribal program presently addressing wildlife and habitat management and Chapter 18 enforcement has to date been designated and known as the Three Affiliated Tribes Fort Berthold Game, Fish and Recreation Department, and
- WHEREAS, Much confusion has arisen from attempting to determine the definitive functions of a department which includes the recreation sector, and
- WHEREAS, As a result of an inability to aptly define in specific terminology the term "Recreation" and it's confinements regarding funding and application, and
- WHEREAS, Because of this lack of ability to define "recreation", the Three Affiliated Tribes cannot determine the limitations of the specific programs that could fall under "Recreation", and further
- WHEREAS, Because the Three Affiliated Tribes recognizes that it must focus full-time efforts towards a proper comprehensive wildlife and management program and Chapter 18 code enforcement in order to protect this valuable Fort Berthold resource, and
- WHEREAS, The Department is still in it's early developmental stages regarding the above mentioned management and enforcement and should address a concentrated effort toward these concerns without diversions which would result from attempting to simultaneously develop and maintain the additional sector of recreation,

NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes Fort Berthold Game, Fish and Recreation Department hereinafter be known as the Three Affiliated Tribes Fort Berthold Game and Fish Department and as such direct it's energies wholly toward the goals of proper wildlife and habitat management.
