WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and

WHEREAS, The Three Affiliated Tribes acquired 3,709 pounds of buffalo meat, and

WHEREAS, The buffalo meat was stored in the Parshall Locker Plant for the Three Affiliated Tribes, and

WHEREAS, The amount now due is \$192.00 covering locker rental from October 3, 1979 up to February 3, 1980.

NOW THEREFORE BE IT RESOLVED that a check be issued in the amount of \$192.00 to cover this expense.
