

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

- WHEREAS: This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and
- WHEREAS: The Constitution and By-Laws of the Three Affiliated Tribes charges the Tribal Business Council of the Three Affiliated Tribes to protect and preserve the property, wildlife and natural resources of the Tribes; and
- WHEREAS: The Fort Berthold Game & Fish Department acknowledges the importance of implementing a proper, comprehensive wildlife and management program, and adheres to the enforcement of Chapter 18 of the Tribal Code; and
- WHEREAS: In order for the Fort Berthold Game & Fish Department Game Wardens to be acknowledged by all Tribal members and non-members as being Game Wardens of the Fort Berthold Reservation, and to enhance the enforcement of Chapter 18 of the Tribal Code, requests the use of uniforms, necessary insignias and weapons for acknowledgement and initial enforcement support; and
- WHEREAS: Upon granted authorization for the use of weapons the Fort Berthold Game Wardens will be subject to Chapter 4B and all Tribal Codes affiliated with the use of weapons and comply with all necessary procedures in which to legally attain the weapons.

NOW THEREFORE BE IT RESOLVED THAT, The Three Affiliated Tribes, Tribal Business Council grants the Fort Berthold Game & Fish Game Wardens the authority to take the proper and necessary legal steps in which to attain Uniforms, insignias and weapons for acknowledgement and enforcement support.
