WHEREAS, Attorneys, Wilkinson, Cragum & Barker (Contract #A00C14201145) have submitted voucher for payment of legal services \$1,057.38, and legal expenses \$97.19, March, 1980; and

THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes' Tribal Business Council hereby authorizes payment in the amount of \$1,154.57 to Wilkinson, Cragum & Barker for the month of March, 1980.
