RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and having authority undersaid Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, A Regular meeting was called on: July 10, 1980
- WHEREAS, According to Article II, Section I: Membership: The membership of the Three Affiliated Tribes of the Fort Berthold Reservation shall consist of:
 - A. All persons whose names appear on the membership of the Tribe as of October 2, 1974.
 - B. Any persons born before the effective date of the amendment and to any member of the Tribe who was a resident of the reservation at the time of birth of said person.
 - C. All persons of at least 1/4 degree Indian blood degree of a federally recognized Tribe, provided at least 1/8 Indian blood be of the Hidatsa(Gros Ventre), Mandan, Arikara(Ree) Tribes.

AMENDMENT VII, DUAL ENROLLMENT:

- A. Persons enrolled with another tribe and who has received benefits for such tribe in the form of land or payments shall not be eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation, provided that the inherited interests shall not be considered as being such benefits.
- B. A person eligible for membership with the Three Affiliated Tribes of the Fort Berthold Reservation and other tribes shall relinquish whatever rights he or she may hold in the other tribe as a condition of his or her enrollment with the Three Affiliated Tribes of Fort Berthold Reservation.
- WHEREAS, This amendment became effective 12:00 A.M. December 12, 1975; and
- NOW THEREFORE BE IT RESOLVED THAT, the Three Affiliated Tribes Tribal Business Council duly and offically disapprove the enrollment of the following applicants under Article II, Section I, C.:
