- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act, and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal members, and
- WHEREAS, the Tribal Natural Resources Committee has approved the exchange of lands between the Three Affiliated Tribes and Jon Dale McGrady under the terms and conditions as stated below, and now

THEREFORE BE IT RESOLVED, that the Tribal Business Council approve the exchange of lands helds in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for Jon Dale McGrady 301-U4970 under the terms and conditions as stated below and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and do **all** things necessary to exchange lands for which title is to be transferred to the United States of America in trust for the Three Affiliated Tribes and Jon Dale McGrady under the terms and conditions as stated below: Allotment Number 301-905A described as the NW45W4 of Section 13, Township 149 North, Range 93 West, fifth principal meridian, North Dakota, containing 40.00 acres, more or less, Appraised at \$3,800.00 For Tribal Allotment 301-743A described as the SEXNEX of Section 9, Township 149 North, Range 94 West, fifth principal meridian, North Dakota, containing 40.00 acres, more or less, difference in value of \$600.00, to be waived by the Three Affilaited Tribes
