## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, A	This	Nation	having	accepte	d the	Indian	Reorganization	Act	of	June	18,
	1934,	and a	uthority	under	said A	Act; and	E				

WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and

WHEREAS, The Three Affiliated Tribes owns a significant amount of surface acreage within the boundaries of the Fort Berthold Reservation; and

WHEREAS, Oil companies have expressed interest in the use of certain tribal lands for drilling well site and access road development; and

WHEREAS, The Tribes may wish to negotiate the fees to be paid to them for the development and use of their lands and must appoint an authorized negoiator to insure and best protect the interests of the Tribes; and

WHEREAS, It is agreed that the Chairman of the Tribal Business Council is knowledgeable in the development area and would act in the best interests of the Tribes,

NOW THEREFORE BE IT RESOLVED, That the Chairman and Secretary of the Three Affiliated Tribes Tribal Business Council be invested with the authority to negotiate these fees for Tribal lands with the respective oil companies and sign the "agreement for Well Site and Access Road Preparation and Use" document as the offical representative of the Three Affiliated Tribes.

- 2) If the site is further developed for production or for any other purpose beyond the drilling activity, renegotiations with the Three Affiliated Tribes must be made prior to any such further development, and
- 3) All conditions and requirements as set out under the Bureau of Indian Affairs and Tribal Construction Regulations and Reclamation Plan must be complied with and adhered to, and
- 4) If at any time, the Oil Company is found to be in noncompliance with any condition set out within this agreement, this agreement will be terminated immediately upon the majority decision of the Three Affiliated Tribes Tribal Business Council.
