

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act, and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes Charge the Tribal Business Council of the Three Affiliated Tribes to protect and preserve the property, wildlife, and natural resources of the Tribes, and

WHEREAS, The current prices paid to surface owners are not sufficient to compensate them for the extent of damages caused by the seismic work now occurring on the Reservation, and

NOW THEREFORE BE IT RESOLVED THAT, resolution #80-75-item 2. be rescinded to read as follows:

2. A minimum of \$350.00 per mile will be paid for any access beyond the permitted line used in seismic exploration. The width of said access road will be no greater than that made by a normal track (truck, pick-up, etc.).

NOW THEREFORE BE IT RESOLVED THAT

1. The shot hole fee be raised from a minimum of \$75.00 per shot hole to a minimum of \$100.00 per shot hole.
2. A minimum of \$10.00 per rod will be paid for any access beyond the permitted line used in seismic exploration.
