Fox, Beverly Fox DeCoteau and Leonard Kelsey Fox, enrolled members of the Three Affiliated Tribes, wish to attend funeral of Cecelia Fox Lindstrom, also an enrolled member of the Three Affiliated Tribes, in Denver, Colorado; and
- WHEREAS, said family of the deceased have no security to obtain a loan from a lending institution(s); and
- WHEREAS, the Tribal Business Council in an effort to aid said family members hereby authorize One Hundred Dollars (\$100.00) loans to each; and
- NOW, THEREFORE BE IT RESOLVED THAT, the Tribal Business Council hereby authorizes One Hundred Dollars (\$100.00) loans to Antoninette Fox LaFromboise, Leland V. Fox, Rocky L. Fox, Ferlon E. Fox, Beverly Fox DeCoteau, and Leonard Kelsey Fox; and
- BE IT FURTHER RESOLVED, that the terms and conditions of said loans shall be twelve (12) months repayment at 5% interest.
