- WHEREAS. The Three Affiliated Tribes' Tribal Business Council has, in April, 1980, submitted their proposal for their F/Y 1981 Indirect Cost Rate; and
- WHEREAS, The audit requirements for that proposal have already been performed; and
- WHEREAS, The F/Y 81 Indirect Costs Rate has yet to be negotiated.
- NOW THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes' Tribal Business Council do hereby request that the Inspector General's Office of the Department of the Interior accept a revised Exhibit - C, Page 6, to the proposal for amendments to support the Tribes' F/Y 81 Operating Budget.
