RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES FORT BERTHOLD RESERVATION

Resolution No. 80-26/

- WHEREAS: This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act, and
- WHEREAS: the Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal memebers, and
- WHEREAS: R. B. Edmundson, Inc., on behalf of the E. G. Helis Estate, has filed an application with the Superintendent, Fort Berthold Agency for an Oil and Gas Unit Agreement called the Clark Creek Unit, and
- WHEREAS: included in the proposed unit agreement is 400 acres of tribally owned minerals, and minerals owned by individual Indians in trust, the Federal Government and fee interests, and
- WHEREAS: Congressional representatives from the State of North Dakota will present to the next session of Congress a bill to return those Federal lands and minerals adjacent to and under the Garrison resevoir within the exterior boundaries of the Fort Berthold Reservation to the Three Affiliated Tribes, and
- WHEREAS: it is not in the best interest of the Three Affiliated Tribes and its members to approve or join in the unit agreement which may jeopardize the return of this property to the Tribe and its members, and now
- THEREFORE BE IT RESOLVED THAT the Three Affiliated Tribes decline at this time to enter into any unit agreement which would include Federal lands adjacent to or under the Garrison resevoir which are within the boundaries of the Fort Berthold Reservation, and
- BE IT FURTHER RESOLVED THAT the Three Affiliated Tribes' Tribal Business Council request that the Bureau of Indian Affairs and U. S. Geological Survey not approve any unit agreement whatsoever that would include those minerals owned by the Federal Government adjacent to and/or under the Garrison resevoir until the U. S. Congress has enacted appropriate legislation or until the ownership of those minerals is resolved.
