RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and having authority under said Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, according to Article II, Section I: Membership: The membership of the Three Affiliated Tribes of the Fort Berthold Reservation shall consist of:
 - A. All persons whose names appear on the membership of the Three Affiliated Tribes as of October 2, 1974.
 - B. Any person born before the effective date of the amendment and to any member of the Three Affiliated Tribes who was a resident of the reservation at the time of birth of said person.
 - C. All persons of at least 1/4 total Indian blood degree of a federally recognized Tribe, provided that at least 1/8 be of the Hidatsa (Gros Ventre), Mandan, Arikara Tribes.

AMENDMENT, DUAL ENROLLMENT:

- A. Persons enrolled with another Tribe and who have received benefits from such Tribe in the form of land or payments shall not be eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation, provided that inherited interests shall not be considered as being such benefits.
- B. A person eligible for membership with the Three Affiliated Tribes of the Fort Berthold Reservation and another Tribe shall relinquish whatever rights he or she may hold in the other Tribe as a condition of his or her enrollment with the Three Affiliated Tribes of Fort Berthold Reservation.
- WHEREAS, This amendment became effective 12:00 A.M., December 12, 1975; and
- NOW THEREFORE BE IT RESOLVED THAT, the Three Affiliated Tribes Tribal
 Business Council duly and offically approve the enrollment of
 Margaret Priscilla Henke, who meets the requirement set in
 Article II, Section I. C. with the sufficient blood degree of
 1/2: 1/4 Hidatsa and 1/4 Canadian Sioux of the Fort Peck Tribe; and
- BE IT FURTHER RESOLVED THAT, the Three Affiliated Tribes Tribal Business Council wholly acknowledges the enrollment of Margaret Priscilla Henke, assigning her the tribal enrollment number of 301-U-6888, thus affirming her natural, inherent right for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation.
