BE IT RESOLVED that the Tribal Business Council hereby approved the purchase of the land described, below exclusive of minerals including oil and gas, from

, which is the present for cash consideration of \$41,400.00 fair market value, utilizing funds from the Judgment Funds account, and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Reservation, to wit:
