RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, The Three Affiliated Tribes desires to continue and to strengthen the Alcoholism Program in its effort to combat alcoholism on Fort Berthold; and
- WHEREAS, The Alcoholism Treatment Program is funded by Indian Health Service from two sections; and
- WHEREAS, The Indian Health Service Community Development funds are necessary to continue partial staffing of the Alcoholism Treatment Center; and
- WHEREAS, The Alcohol Treatment Program has improved and strengthened the Therapeutic treatment services to clients; and
- WHEREAS, The improved therapeutic treatment is evidenced by the increased number of "walk ins" who recognize the value of the support system available; and
- WHEREAS, The two counselors, following training, provide supervised individual therapy for the clients; and
- WHEREAS, The cook has also participated in staff training; and
- WHEREAS, The improved treatment has necessitated an improved record keeping system; and
- WHEREAS, The Alcoholism Guidance System as developed by Indian Health Service, enables the staff to plan, implement and evaluate the treatment program; and
- WHEREAS, A Data Clerk is necessary to maintain an effective alcoholism guidance system; and
- WHEREAS, The Three Affiliated Tribes will continue the improvement of the Alcohol Treatment Program;
- THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes requests \$40,043 Indian Health Service Community Development funds with which the Alcoholism Treatment Center will be partially staffed.
