RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and

WHEREAS, Article VI, Section 5, of the Constitution of the Three Affiliated Tribes empowers the Tribal Business Council to issue Tribal Charters to organizations and enterprises; and

WHEREAS, the Tribal Business Council of the Three Affiliated Tribes has issued a charter incorporating the Fort Berthold Communications Enterprise; and

WHEREAS, the Fort Berthold Communications Enterprise will be addressing itself to the communication needs of individuals residing within the exterior boundaries of the Fort Berthold Reservation; and

WHEREAS, the Fort Berthold Communications Enterprise has submitted its application for a license to operate to the Federal Communications Commission and has shown a local commitment for three months operating expense and a twenty-five percent (25%) matching fund for the entire cost of construction of the radio facility; and

WHEREAS, the Tribal Business Council of the Three Affiliated Tribes recognizes the importance of improved communications for the various Reservation segments; and

WHEREAS, the Three Affiliated Tribes were awarded monies under Docket 350-F;

WHEREAS, the allocation to Fort Berthold Communications Enterprise under Resolution No. 80-184 is insufficient due to the increased calculated costs,

THEREFORE BE IT RESOLVED, Resolution No. 80-184 be rescinded.

FURTHER RESOLVED, that due to the calculation of additional costs and allowances for inflation the Tribal Business Council of the Three Affiliated Tribes allocates \$67,262.00 from the Public Facilities Fund under Docket 350-F to be utilized for the purpose of providing the requested twenty-five (25%) match for construction of the radio facility and three months operating cost.
