- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, The Tribal Business Council has studied the benefits of engaging in a process of improving its Comprehensive Planning and Management capabilities; and
- WHEREAS, The Tribal Planning Department has adapted a Planning/Management Process to fit the specific needs of the Three Affiliated Tribes; and
- WHEREAS, Proceeding with this Process shall allow the Three Affiliated Tribes to attain a greater degree of self-sufficiency and more fully exercise sovereign governmental powers;
- THEREFORE BE IT RESOLVED, the Tribal Business Council hereby adopts the attached "Three Affiliated Tribes Long Range Planning/Management Model" as the official Planning/Management Process for use by the Three Affiliated Tribes.
- FURTHER RESOLVED, that under the direction of the Tribal Business Council the Planning/Management Coordination Team shall proceed with the proper steps to implement the Process.
