- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, Attorneys, Wilkinson, Cragun and Barker, Contract #A00C-1420-1145, have submitted voucher for payment for legal services, \$1761.60, and legal expenses, \$89.78, for the month of December, 1980; and

THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby authorizes payment of \$1,851.38 to Wilkinson, Cragun and Barker, for legal services and expenses for December, 1980, from attorney fees.
