- WHEREAS, There have been numerous animal damage problems arising each year from the activities of coyotes, beaver, and prairie dogs on Reservation lands; and
- WHEREAS, The U.S. Fish and Wildlife Service has agreed to supply personnel and equipment as available and work cooperatively with Natural Resources Department personnel in the alleviation of the animal damage problems on a request basis; and
- NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council fully authorizes the Natural Resources Department in cooperation with the U.S. Fish and Wildlife Service to alleviate animal damage problems on the Reservation; and
- BE IT FURTHER RESOLVED, That Tribal Business Council Resolution No. 75-12 (attached) be rescinded.

- WHEREAS, H. Kinden of New Town has his own plane at his disposal, and,
- WHEREAS, hunting from the air may be a solution to help reduce the coyote population,
- NOW THEREFORE BE IT RESOLVED THAT, the Tribal Business Council of the Three Affiliated Tribes authorize H. Kinden to hunt coyotes on the reservation where there is a coyote problem.
