- B. The Tribal Personnel Selection Committee(s) shall be (1) Executive Committee (2) Material Resource Committee (3) Natural Resource Committee (4) Human Resource Committee (5) Judiciary Committee The Department Administrators for the above named shall also participate in the slection of positions within their respective departments with the understanding that they are the supervisors of all employees within their department.
 - 1. The Tribal Personnel Selection Committee shall:
 - a. The positions hired by the Executive Committee are as follows:
 Programs Management staff, Personnel Office staff, Planning
 Department staff, Finance Office staff and staff for the
 Tribal Business Council.
 - b. The four (4) Tribal Business Council committees shall hire all Tribal employees in their respective departments, with the exception of program directors and equivalent managers. Program directors and equivalent managers will be hired by the members of the Tribal Business Council.
 - c. Be responsible for all matters pertaining to the hiring, advancement, discipline, and removal of any and all Tribal Employees performing work in connection with Tribal, Federal and State programs.
 - d. Be responsible for promulgating standards for employment, working conditions, job descriptions, wage and promotion scales, delineation of duties and procedures in accordance with policies and procedures as established by the Human Resource Committee and program governing boards.
 - e. Delegate the responsibility of discipline of employees, e.g., letters of warning and suspension, but not including terminations, to the program directors and equivalent managers.
