- WHEREAS, John O. Holm in the litigation of said lawsuit has expended \$580.50 in time and expenses to date:
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council authorizes payment in the sum of \$580.50 to John O. Holm for the work performed to date with respect to the lawsuit of Three Affiliated Tribes v. Wold Engineering.
