- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, the Fort Berthold College is providing quality educational services to the organizations and the people of the Fort Berthold Indian Reservation; and
- WHEREAS, the Three Affiliated Tribes of the Fort Berthold Reservation fully supports the continuing improvement of the Fort Berthold College; and
- WHEREAS, the Fort Berthold Community College seeks to provide training and educational services reflective of Community Development needs; and
- WHEREAS, the Fort Berthold Community College seeks to develop said interest through the application for funding to the National Center for Appropriate Technology;
- THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes of the Fort Berthold Reservation does not wish to be prime contractor but certifies that the Fort Berthold Community College is preferable for carrying out this activity.
- BE IT FURTHER RESOLVED, that this resolution serves as a certificate evidencing that Fort Berthold Community College has sought and has received tribal support in this regard.


