## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and having authority under said Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, A Special meeting was called on April 16, 1981; and
- WHEREAS, According to Article II, Section I: Membership: The membership of the Three Affiliated Tribes shall consist of:
  - A. All persons whose name appear on the membership of the Tribe as of October 2, 1974.
  - B. Any persons born before the effective date of the amendment and to any member of the Tribe who was a resident of the reservation at the time of birth of said person.
  - C. All persons of at least 1/4 degree Indian blood of a Federally recognized Tribe provided at least 1/8 Indian blood be of the Hidatsa (Gros Ventre), Mandan, Arikara (Ree) Tribe.

## AMENDMENT VII, DUAL ENROLLMENT:

- A. Persons enrolled with another Tribe and who have received benefits from such Tribe in the form of land or payments shall not be eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation, provided that the inherited interests shall not be considered as being such benefits.
- B. A person eligible for enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation and another Tribe shall relinquish whatever rights he or she may hold in the other Tribe as a condition of his or her enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation; and
- WHEREAS, The children and grandchildren of Elizabeth Nagle Mitchell, 301-A-01486, 1/2 Mandan, are seeking enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation; and
- WHEREAS, All the required documentation has been provided to verify their enrollment eligibility; and
- WHEREAS, The Mitchell children and grandchildren have requested relinquishment from the Santee Sioux Tribe of Winnebage, Nebraska, but must have their enrollment with the Three Affiliated Tribes secured in order for them have their names removed from the Santee Sioux Tribe's enrollment; and

WHEREAS, Further verification was requested from the Tribal Business Council at a Regular meeting, April 10, 1981, as to whether or not the Mitchell children and grandchildren had received any land or payment benefits as set forth in Amendment VII, Dual Enrollment of Articel II, Section I: Membership Code; and

NOW THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes Tribal Business Council of the Fort Berthold Reservation approve the enrollment of Elizabeth Nagle Mitchells' children and grandchildren, utilizing and acknowledging their completed enrollment applications and their completed relinquishment forms from the Santee Sioux Tribe of Winnebago, Nebraska, as sufficient, required documentation to their full compliance to the Three Affiliated Tribes: Article II, Section I: Membership: AMENDMENT VII, DUAL ENROLLMENT: B.: A person eligible for membership with the Three Affiliated Tribes and another Tribe shall relinquish whatever rights he or she may hold in the other Tribe as a condition of his or her enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation; and

BE IT FURTHER RESOLVED, that the Three Affiliated Tribes Tribal Business Council of the Fort Berthold Reservation accepts the verification from the Aberdeen Area Office, April 10, 1981, as total validation of the Mitchell children and grandchildren's compliance with the requirements set forth in the Three Affiliated Tribes Membership Code.
