

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES
FORT BERTHOLD RESERVATION

Resolution No. 82-18

- WHEREAS: This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act, and
- WHEREAS: The Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal members, and
- WHEREAS: the Tribal Business Council passed Tribal Resolution No. 81-202 purchasing Fee Patent property owned by Edwin A. Hall pending Title Opinion of the Field Solicitor, Aberdeen Area, and
- WHEREAS: the title to the Fee Patent property described as Lots 1, 2, E $\frac{1}{2}$ NW $\frac{1}{4}$, Sec. 31, T. 151 N., R. 94 W., exclusive of minerals, containing 309.36 acres, has been found to contain a forced patent in fee without consent of the owner, and
- WHEREAS: said property will be involved in litigation brought by the Branch of Rights Protection under 28 USC 2415 Claims, and
- THEREFORE: BE IT RESOLVED that the Tribal Business Council hereby rescinds Tribal Resolution No. 81-202 purchasing the above described land.

Resolution No. 81-207

- WHEREAS: This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act, and
- WHEREAS: The Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal members, and
- WHEREAS: the Natural Resources Committee of the Tribal Business Council approved the purchase by the Tribe the land described below and
- WHEREAS: it has been determined that it is in the best interest of the Tribe to acquire the land, and now
- THEREFORE: BE IT RESOLVED that the Tribal Business Council hereby approved the purchase of the land described, below exclusive of minerals including oil and gas, from

Edwin A. Hall

for cash consideration of \$42,000.00, which is the present fair market value, utilizing funds from the Land Purchase/Judgment account, and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Reservation, to wit:
