the title to the Fee Patent property described as Lots 1, 2,  $E_2^1NW_4^1$ , Sec. 31, T. 151 N., R. 94 W., exclusive of minerals, containing 309.36 acres, has been found to contain a forced

patent in fee without consent of the owner, and

WHEREAS:

said property will be involved in litigation brought by the Branch of Rights Protection under 28 USC 2415 Claims, and

THEREFORE:

BE IT RESOLVED that the Tribal Business Council hereby rescinds Tribal Resolution No. 81-202 purchasing the above described land.

for cash consideration of \$42,000.00, which is the present fair market value, utilizing funds from the Land Purchase/Judgment account, and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Reservation, to wit:
