Jailer Dispatcher

WHEREAS, The BIA advises that we are to submit a program budget based on 75% of the lessor tenative FY 82 or 83 allocations;

NOW THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes under the Authority of PL 93-638 recontract for a one (1) year period beginning October 1, 1982 through September 30, 1983

BE IT FUTHER RESOLVED, that the program budgets shall be submitted at the 75% of the lessor FY 82 or 83 allocations as follows:
