- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, On September 21, 1982, the Three Affiliated Tribes will be conducting a General Election; and
- WHEREAS, In accordance with the Tribal Constitution and Tribal Election Ordinance
 Part IV, Section 1(a), the Tribal Business Council shall appoint a Tribal
 Election Board of five (5) qualified voters to conduct the General Election,
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby appoints the following qualified voters to serve as the Tribal Election Board:
