

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

TRIBAL GOVERNMENT EDUCATION ASSISTANCE AGREEMENT  
WITH THE INDIANS INTO MEDICINE (INMED) PROGRAM

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorize and empower the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, The Fort Berthold Reservation has always been considered a formal part of the INMED Program, and
- WHEREAS, The Fort Berthold Reservation has designated INMED Advisory Board members and been helpful in setting board policy, and
- WHEREAS, The INMED Program has scholarship monies for undergraduate, medical students, and other allied health students including a high school summer institute, and
- WHEREAS, The INMED Program has five slots in the medical school in addition to the regular medical school class, and
- WHEREAS, The INMED Program has health materials and publications designated to increase the awareness and interest of Indian people in health careers, and
- WHEREAS, The Scholarship Program from Indian Health Service is starting to prove itself to meet the needs of Indian people, and
- WHEREAS, The INMED Program has enabled more Indian students to receive an MD degree from any other program, and
- WHEREAS, The attached resolution of support has been sent to the INMED office by the reservations in the INMED area, and
- WHEREAS, The Chairman of the Advisory Board is elected to oversee the tribal interests in INMED, and
- WHEREAS, There is a proposed phase out of the Scholarship Program and INMED by Indian Health Service,
- THEREFORE BE IT RESOLVED, that the Chairman of the Advisory Board on behalf of the twenty-two reservations in the five-state area of INMED - approximately 100,000 people - requests continuation of funding for the INMED Program and funding for the new scholarships each year.
