## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorize and empower the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, The Fort Berthold Transportation Commission was established pursuant to Resolution #82-35, and
- WHEREAS, The Tribal Business Council assisted the Commission with \$2,000 to cover consultant fees and operating expenses, and
- WHEREAS, The fees to be charged for trucking on the Fort Berthold Reservation will not be collected until hearings are held, and

THEREFORE BE IT RESOLVED, that the Tribal Business Council authorizes a loan of \$3,000 from the Tribal T/2 Account to cover salary and expenses for the Transportation Commission (budget attached), and

BE IT FURTHER RESOLVED, that the Fort Berthold Transportation Commission shall repay \$3,000 to the Tribal Business Council when income to the Commission becomes available.
