- WHEREAS, The Three Affiliated Tribes is one of the host tribes for the 39th Annual Convention of the National Congress of American Indians (NCAI) which is scheduled to be held September 26-October 1, 1982 in Bismarck, North Dakota; and
- WHEREAS, Mssrs. John Fox, Sr., Alfred Driver, Bill Baker, Angus Fox and Norman Baker will be representing the Three Affiliated Tribes as host drum for the NCAI Convention; and
- WHEREAS, The Tribal Business Council desires to compensate said members for representing the Three Affiliated Tribes at NCAI;
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council hereby authorizes payment in the amount of \$500.00 to John Fox, Sr., Alfred Driver, Bill Baker, Angus Fox, and Norman Baker for representing the Three Affiliated Tribes at the 39th Annual NCAI Convention from the Tribal T/2 Account.
