NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council hereby approves the attached Budget for the Tribal Business Council for FY 1983; and

BE IT FURTHER RESOLVED, that the Tribal Treasurer and Tribal Comptroller shall see to it that this budget is followed to its utmost and that any deviation from this budget shall be by further resolution only.
