

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, The Three Affiliated Tribes received a judgment award from the United States Government in 1978 under Dockets 350 C& D; and
- WHEREAS, The 20% programming aspect of the judgment distribution plan amounted to \$1,936.579.19, and according to the plan approved by the Tribal members and Congress, it required that the interest earned on the principal be budgeted annually by the Tribal Business Council for the categories approved under the plan; and
- WHEREAS, The Community Development Fund is one of the categories for which the interest earned would be allocated to for community development projects;
- WHEREAS, In FY 1983 the amount to be allocated for community development will be \$149,000.00;
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council hereby allocates to the six communities on Fort Berthold Reservation their share of community development funds for FY 1983 to be determined as follows:
