

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES  
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act; and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal members; and

WHEREAS, The Tribal Business Council hereby approves the payment of all taxes due on Fee Patent property and city lots acquired by the Three Affiliated Tribes; and

WHEREAS, It has been determined by the Tribal Business Council that taxes due, be paid under protest, on all properties owned by the Three Affiliated Tribes until a Solicitor's opinion is obtained from the Area Solicitor's Office; and

THEREFORE BE IT RESOLVED, That the Tribal Business Council hereby approves the payment of all taxes due, under protest, for the following described properties to the respective County Treasurer's Office, which have accumulated through 1982 and are to be paid January 1, 1983:


BE IT FURTHER RESOLVED, That the above taxes be paid out of


I, the undersigned, as Secretary of the Tribal Business Council of
