WHEREAS, the indirect cost rate proposal is not done for Fiscal 1983; and

WHEREAS, departments normally paid from the Indirect Cost Pool have been operating and need to continue to operate for Fiscal 1983; and

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council authorizes all expenses for departments normally paid from the Indirect Cost Pool be paid from Tribal Funds until a Fiscal 1983 Indirect Cost rate is approved; and

NOW, BE IT FURTHER RESOLVED, that after a Fiscal 1983 Indirect Cost Rate is approved, tribal funds will be reimbursed from the Indirect Cost Pool.
