## RESOLUTION OF THE GOVERNING BODY OF THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and authority under said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefits of the Tribe and tribal members; and
- WHEREAS, Red Eagle Productions is 100% Indian owned minority video production company which has the facilities and capabilities to produce professional television programs for the Three Affiliated Tribes; and
- WHEREAS, The Three Affiliated Tribes is desirous of having a television program of one ½ hour per month devoted strictly to the history, culture and current happening of activities on the Fort Berthold Reservation; and
- WHEREAS, The Tribal Council is devoted to keeping the Three Affiliated Tribes members better informed through the video media.
- NOW THEREFORE BE IT RESOLVED that the Executive Board is empowered to enter into a contract with Ron Holt, d/b/a Red Eagle Productions, Box 612, Crow Agency, Montana 57022 to provide one television program of one-half (½) hour per month for twelve (12) months with the following stipulations:
  - a. All video tapes, and footage not used, shall be the property of the Three Affiliated Tribes for historical and preservation purpose.
  - b. The Three Affiliated Tribes does hereby appropriate a sum not to exceed \$30,000 or \$2,400 per month for social program.
  - c. The Three Affiliated Tribes shall not be responsible for compensating any television station for the air time of such shows.
