RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and

WHEREAS, The Three Affiliated Tribes adopted a Tribal Business Council budget for Fiscal Year 1983 by Resolution No. 83-190; and

WHEREAS, The Tribal Business Council has an operating statement for the first quarter of operation and it is evident that changes in budget line items is necessary; and

WHEREAS, There is excessive revenues totaling \$450,000 in the FmHA Land Revenue Account maintained at the BIA office; and

WHEREAS, Additional funds are needed for the Tribal WAke Fund, Community College, and Tribal Newspaper and Radio Station; and

WHEREAS, The Tribal Business Council has a need for additional funds in their operating budget to purchase land, pay a rebate to Indian ranchers and refund overdrafts on Letters of Credit occurring in previous years;

NOW THEREFORE BE IT HEREBY RESOLVED that the Three Affiliated Tribes, Tribal Business Council approves the attached budget revision #1 as the Tribal Business Council operating budget for Fiscal Year 1983;

BE IT FURTHER RESOLVED that the Bureau of Indian Affairs is requested to pay the excess funds totaling \$450,000 in the FmHA Land Revenue Account to the U. S. Treasury so it may be made available for inclusion in the Tribal Budget;

BE IT FURTHER RESOLVED that interest funds from Docket 350-G be included for the Tribal Wake Fund, Community College, and the Tribal Newspaper and Radio Station as itemized in the attached budget.
