- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, the Administration for Native Americans has established social/ economic self-sufficiency within the framework of Indian selfdetermination as its policy and focuses its financial resources toward capacity building of Tribal Governments; and
- WHEREAS, the Three Affiliated Tribes have utilized this opportunity through the 1980, 1981, and 1982 ANA Grant Periods to fund a Comprehensive Planning and Management Process which is leading to improved Tribal Government capabilities, greater self-sufficiency, and greater self determination; and
- WHEREAS, the Administration for Native Americans has invited the Three Affiliated Tribes under Program Announcement 13.612-831 to submit a refunding Application for the 1983/84 Grant Period (July 1, 1983 to June 30, 1984); and
- WHEREAS, the Tribal Business Council must make certain assurances in compliance with Department of Health and Human Services and Administration for Native Americans regulations;
- THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the execution and filing of the attached Grant No. 80914 application for financial assistance from the Administration for Native Americans for the ANA 1983/84 Grant Period of July 1, 1983 to June 30, 1984, including all understandings and assurances contained in the Application,
- FURTHER RESOLVED, that the Grant Application represents a Total Project Cost of \$1,718,077.00 which consists of two major sections the Tribal Matching Cost Section and the Administration for Native Americans Financial Assistance Request Section,
- FURTHER RESOLVED, that the Tribal Matching Cost Section shall be constructed as follows:
