- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, the Tribal Business Council has approved the Tribal Comprehensive Planning and Management Process; and

- WHEREAS, tribal Staff and the Tribal Business Council have participated in meetings and work sessions which have resulted in completing the initial steps in that process; and
- WHEREAS, the attached planning document is a "first draft" which can be the basis for further progress in the Process; and
- WHEREAS, the Three Affiliated Tribes is awaiting the results of the compilation of the Economic and Quality of Life Survey so that analysis of economic and service indicators may proceed; and
- WHEREAS, further progress must be accomplished if the Comprehensive Planning Management Process is to benefit the Three Affiliated Tribes; and
- WHEREAS, the Administration for Native Americans requires that General Tribal Needs and Long Term Goals be addressed (Part IV Narrative Instructions Numbers la and 1b) and will evaluate grantee proposals based on their stated plans and their developmental strategies (ANA Evaluation Criteria Number 1);
- THEREFORE BE IT RESOLVED, that the Tribal Business Council adopts the attached Three Affiliated Tribes Comprehensive Plan Draft 1 as a basis for further work to be accomplished in the Comprehensive Planning/Management Process and directs the Tribal Staff to continue their efforts in completing that Process,
- FURTHER RESOLVED, that the Three Affiliated Tribes Comprehensive Plan Draft 1 shall serve as an official attachment to the proposal being presented to the Administration for Native Americans under Program Annoucement No. 13,612,831 and shall be utilized to meet the requirements of the Part IV Narrative Instructions Number 1a-1b for Criteria Number 1.
