## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activites for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, The cemeteries in Fort Berthold need general cleaning to maintain good appearance not only to enrolled members but to other people who view these cemeteries; and
- WHEREAS, Sally White, an enrolled member, has offered her services to the Tribal Business Council to clean these areas,
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council approves a consultant agreement with Sally White to clean cemeteries with the following:
  - April 15, to May 15, 1983 \$350.00; not to exceed \$200.00 for travel allowance @ .20c per mile and start-up tools and equipment not to exceed \$500.00

    TOTAL \$1,050.00
  - May 15, to June 15, 1983 \$350.00 salary; not to exceed \$200.00 for travel allowance @ .20c per mile. TOTAL \$500.00
  - June 15, to September 15, 1983 \$350.00 per month salary x 3 months. \$200.00 for travel allowanc- @ .20¢ per mile x 3 months = \$600.00. TOTAL \$1,650.00

## TOTAL SUM - \$3,250.00

- BE IT FURTHER RESOLVED, that these monies shall be paid from the Tribal Business Council consultant line item, and that monthly reports must be submitted to the Human Resource Committee.
- BE IT FURTHER RESOLVED, that payment shall be month to month upon satisfactory completion of monthly reports to the Human Resource Committee.
- BE IT FURTHER RESOLVED, that upon completion of the consultant agreement that all tools/equipment purchased with tribal money be returned to the Tribal Business Council for possible future similar work
