## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, P.O. 93-638, 25 CFR 273.31 mandates that Johnson O'Malley funds be distributed on a substantially equal basis; and
- WHEREAS, P.L. 95-561, Section 1102(b) states, "the Secretary of Interior shall establish and publish the formula which the majority of the eligible Tribes determine by vote to be the most equitable"; and
- WHEREAS, the present Johnson O'Malley formula implemented in FY 1981 is not an equitable formula; and
- WHEREAS, the decision by the Assistant Secretary of Interior in June of 1979 which determined that each Alaskan Village would have one vote amounts to an abuse of his discretionary authority; and
- WHEREAS, said decision violates the equal protection rights guaranteed by the 5th Amendment of the United States Constitution; and
- WHEREAS, said decision further works to the detriment of a substantial portion of eligible Indian children, and ultimately to the detriment of a substantial portion of all Indian Tribes; and
- WHEREAS, P.L. 95-561, Section 1102(b) mandates that the Secretary shall revise such formula periodically as necessary; and
- NOW, THEREFORE, BE IT RESOLVED, that the Secretary of Interior take immediate and necessary action to revise the existing Johnson O'Malley formula to ensure that each eligible student receive equal share.
- BE IT FURTHER RESOLVED, that is the process of revising the Johnson O'Malley funding formula, that the Secretary abolish the precedent established in 1979, whereby each Alaskan Village/Corporation was determined to be an Alaskan Native Governmental entity fully eligible to vote on an equal basis with the Federally Recognized Tribes; and
- BE IT FURTHER RESOLVED, that until such time as the Secretary publishes the aforementioned formula revision, he take the necessary steps to establish an interim funding formula that will guarantee each eligible Johnson O'Malley student an equal share of the Johnson O'Malley appropriation.
