## JUSTIFICATION

This grant is to improve the tribal communication system on the Fort Berthold Reservation; however, the line item for Contractual is overbudgeted. The Tribe therefore proposes to add secretarial services, the position to be known as Communication Officer. The amount of over-budget is \$9,600.00. The position description for the Communication Officer is attached. The starting date for the position is July 1, 1983. This position will aid the Tribal Government in communications by providing resolutions, minutes, and other pertinent information to the tribal newspaper and other news media on behalf of the tribe; the incumbent will also coordinate the activities of the Community Information Officers (5) by disseminating information, minutes and resolutions to the tribal constituency; the incumbent will also aid tribal government by typing minutes and resolutions for Tribal Business Council approval and maintaining a neat and orderly file system for the Business Office of all minutes and resolutions.
