WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority under said Act, and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes Charges the Tribal Business Council of the Three Affiliated Tribes to protect and preserve the property, wildlife and natural resources of the Tribes, and

WHEREAS, The Tribal Council, the Natural Resources Department and Tribal members have expressed an interest in developing additional recreation areas on Lake Sakakawea within the Fort Berthold Reservation, and

WHEREAS, The Corps lands that are involved are currently in grazing status and have to be changed to recreation status for development to occur, and

WHEREAS, These additional recreation Areas will provide income and jobs to the Tribal members.

NOW THEREFORE BE IT RESOLVED That, the attached list of Corps lands be designated as Recreation Areas.
