- THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes approved the assignment of grazing revenue to be used at a finance institution to secure the lease/purchase of the computer hardware.

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and

WHEREAS, the Three Affiliated Tribes' Tribal Finance has determined the computerized accounting system, the Burrough's B-80, is inadequate in producing sound financial control for the Tribe; and

WHEREAS, the Three Affiliated Tribes, Tribal Finance wishes to utilized an IBM System 34 for all financial reporting including Payroll, General Ledger, Property & Supply Inventory and Accounts Payable. The purchase will be made by lease purchase.

NOW, THEREFORE, BE IT RESOLVED, that the Three Affiliated Tribes' Tribal Business Council approve the lease purchase of the IBM System 34 and shall pay the monthly installments of under \$1,200.00 from the Tribal Business Council T/2 account beginning with the month of October, 1983. For any monthly rentals paid prior to October, 1983, these will be paid from interest income being earned on "Money Market" bank account.
