RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- WHEREAS, the Three Affiliated Tribes adopted a Tribal Business Council Budget for Fiscal Year 1983 by Resolution No. 83-190; and
- WHEREAS, the Tribal Business Council has an operating statement for the first nine months of operation and it is evident that changes in budget line items are necessary; and
- WHEREAS, there are revenues totaling \$258,544.00 available. These revenues are \$108,604.00 of Trust Funds interest, \$14,886.00 Money Market interest and Miscellaneous income of \$6,800.00, repayment due from White Shield and prior years cash carryover of \$128,254.00; and
- WHEREAS, the Tribal Business Council needs funds to meet obligations for the remainder of the current fiscal year; and
- WHEREAS, the modification needed to meet obligations are those shown on the attached modification; this is a budget increase of \$267,548.00; and
- WHEREAS, a funding shortfall of \$9,004.00 exists; and
- NOW, THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes, Tribal Business Council approved the attached Budget Revision #2 as the Tribal Business Council operating budget for Fiscal Year 1983; and
- BE IT FURTHER RESOLVED, that additional funds described above include \$98,000.00 under Docket F, Tribal Administration, and \$92,000.00 from Docket C & D under Tribal Administration.
