- WHEREAS, the Tribal Business Council has provided a line item in their 1983 budget to pay prior years overruns.
- NOW THEREFORE BE IT RESOLVED THAT THE TRBAL BUSINESS COUNCIL APPROVES PAYMENT OF THE ATTACHED LIST OF PRIOR YEARS OBLIGATIONS TO BE CHARGED AGAINST THE LINE ITEM PROVIDED.
