- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and
- WHEREAS, A standard mileage form is needed for tribal programs; and
- WHEREAS, In accordance with the Three Affiliated Tribes, Personnel Policies and Procedures Handbook, Section TRAVEL, Part B. 2. a mileage form has been prepared to include speedometer readings; and
- NOW, THEREFORE, BE IT RESOLVED, that the attached mileage form be adopted as the official form to be used by all tribal programs, so that the mileage form will be standardized.
